## How does the council use evidence based and best practice to influence resident behaviour change to boost recycling?

**Recommendation 1:** Take forward the case study brought by Committee Member of a development in their ward to see how the planning process has been working historically

#### **Comments from Service:**

We will use case studies to help develop the final version of our new Supplementary Planning Guidance. This will involve review of lessons learnt from the case studies to improve on the planning process.

The Tower Hamlets Local Plan 2031 sets out how and where new development should come forward. A part of the overarching vision in the Local Plan focuses on high standards of environmental sustainability to achieve improved air quality, reduce carbon emissions, increase recycling and mitigate climate change. The way in which waste is produced and managed will affect the chances of the vision being realised.

The Tower Hamlets Local Plan includes a policy (DMW3) that requires proposals for new developments to take full account of how waste will be produced and collected. In order to assist architects and developers to meet the requirements of policy DMW3, the Public Realm division had prepared supplementary planning guidelines, setting out the council's expectation in terms of external storage capacity for waste and recycling and providing information about the nature of the waste and recycling service provided by the council and the design aspects necessary in order that the new development conforms to the council's service methodology.

Officers within waste services have historically provided comments on planning applications on the basis of these supplementary planning guidelines and objections have been made via the planning officer, when proposals haven't met the guidelines.

In order to improve the waste management legacy from new developments, by seeking to increase waste reuse and recycling and require developers to have a greater focus on the "user journey", a new Reuse, Recycling and Waste Supplementary Planning Document (RRW SPD) is being developed. The SPD will require developers to compile a reuse recycling and waste plan and submit this to the council as part of the planning application. The plan must consider all five stages of waste

management that will take place in the development once it is occupied:

- Occupier separation
- Deposit points for reuse recycling and waste
- Collection from the development
- Servicing of the reuse, recycling and waste system
- · End destination and ongoing monitoring

Going forward, the Technical Officer – Development Control, within the Environmental Services Improvement Team, will review the reuse, recycling and waste plans submitted by developers and will provide comments to the planning officer as to whether the plan conforms to the requirements set out in the SPD and whether or not the proposals are acceptable. As the Plan must cover how the development will be managed once occupied, a part of the process will be to engage with managing agents to provide guidance on signage and communication materials to help influence resident's behaviour upon moving in.

The draft SPD is currently undergoing public consultation and will be presented to the Mayor in Cabinet in due course for adoption.

Recommendation 2: Review the location of estate bins to minimise contamination by passers-by

#### **Comments from Service:**

This is part of the process for rolling out the estates recycling improvement package. It will include site assessments to find best location for bins that help reduce abuse and contamination from passers by.

This will require agreement from the managing agent and landlord.

It is the responsibility of the managing agent or landlord to provide adequate recycling facilities for their residents, to ensure they are conveniently located and that the recycling is not contaminated with incorrect materials at the time of collection. Through the Estates Recycling Improvement Project work is in progress to roll out new recycling facilities (the flats recycling package) on a proportion of Tower Hamlets Homes Estates. The flats recycling package includes the use of reverse lid lock bins and improved signage that help to reduce contamination and inform residents about what can be recycled.

Promoting the use of reverse lid lock bins and the wider flats recycling package to other managing agents and landlords may help

to reduce contamination. ReLondon (previously Resource London) has developed a cost benefit tool to assist managing agents to understand the benefits of rolling out the flats recycling package on their estates. Information and advice on best practice will be disseminated through the Public Realm sub-group of the Tower Hamlets Housing Forum. A dedicated webpage is also being developed to provide managing agents and landlords with information and access to communications materials that can be used to help inform and support their residents to use the recycling facilities correctly.

Where site visits have been undertaken and they have highlighted that the bins are in a location that leaves them exposed to abuse by others a request can be made to the managing agent or landlord to consider relocation.

Recommendation 3: Making changes to physical barriers to help influence positive behaviour change

#### **Comments from Service:**

The flats recycling package the service is rolling out is based on two years of research that have identified barriers to positive behaviour change. The flats recycling package focuses on providing common service standards that help reduce physical barriers and influence positive behaviour change.

The flats recycling package includes:

- Clean and well-maintained bins and bin areas
- Adequate collections to prevent overflows and appropriate recycling capacity (minimum 60l/hh/wk)
- Appropriate apertures on recycling bins big enough to accept plastic bags of recycling and with locked reverse lids
- Collection of the six main recyclable materials
- Clear and visible signage on and above the bins
- Convenient location of recycling bins for residents
- Recycling leaflet sent to residents once a year
- Posters highlighting recycling messages displayed in a central location (where possible)
- · Residents informed of what they should do with bulky waste

Key recommendations from the research include: • Housing providers, building managers and service providers can improve recycling capture rates in purpose-built flats by working together to put in place and maintain the standards defined in the Flats Recycling Package on every estate. • The ReLondon Flats Recycling Package toolkit offers practical advice and guidance to help housing providers, building managers and services providers to implement the Flats Recycling Package in purpose-built flats. The toolkit will be available in March 2020.

As part of rolling this package out to THH estates in 2020/21 we are fine tuning this approach. To understand the cost / benefits and promote wider take up of the toolkit for introducing the flats recycling package

## The planning, design and build of new development will also include designing out of physical barriers

A key focus of the Reuse Recycling and Waste SPD is to require developers to implement more innovative mass collection systems for new larger developments such as the underground bins or Automated Waste Collection Systems (AWCS) such as the system used at the Wembley development, rather than continued reliance on standard bin rooms and communal euro containers. Such systems utilise small above ground apertures for waste and recycling to be deposited making the facilities easier to use for many residents.

Overcoming the physical barriers in existing property stock could be difficult, smaller bins are not always suitable especially now the quantity of cardboard is increasing. The reverse lid lock bins being rolled out to THH estates should prove to be easier to use in some respects, as you do not need to open the whole lid to place recycling inside, only the flap to the aperture.

Where this issue is identified, the matter could be raised with the managing agent as caretaking teams may be able to offer assistance to residents. If this option is not available the managing agent would be recommended to change to reverse lid lock bins.

A key element of the Flats Recycling Package is to ensure bin areas are clean and well maintained and to make sure recycling bins are in convenient and accessible locations with clear signage. This is seen as critical to motivate residents to recycle more.

Recommendation 4: Reconsider clear bag provision for flats as an intervention to aid behaviour change on recycling

#### **Comments from Service:**

Plastic recycling sacks have been used to support the council's dry recycling service for some time. A proportion of the housing stock in Tower Hamlets (houses and flats above shops without their own recycling wheelie bins) relies on the recycling sacks as their only method of containment for their co-mingled dry recycling. However, residents in flats have come to rely on the recycling sacks despite the ability to place recycling loose into the communal recycling bins.

The distribution of recycling sacks is currently focused on the following methods:

- Twice yearly delivery of supplies of recycling to approximately 24,000 properties on the kerbside sack collection service. The delivery takes place each June and December, providing in total 104 recycling sacks to each household.
- Provide supplies of sacks to designated pick up points, e.g. Idea Stores, and a small number of additional community locations, on a regular basis. Residents who live in houses or flats are able to collect recycling sacks from these designated pick up points.

The current budget available for the distribution of recycling sacks is only sufficient for a limited quantity of recycling sacks to be provided to the pick up points each week.

Whilst the plastic sacks have low value in terms of a secondary recyclable material and if used and disposed of incorrectly have a potential to create litter, the ability for residents living in flats to obtain the plastic recycling sacks provides a conduit through which they can take part in the recycling service. However, as residents who live in high rise properties have access to communal bins it is possible for them to actively engage in recycling by placing their materials loose in the communal bins and our communications messages promote placing recycling loose in communal bins.

The reverse lid lock bins, that are being rolled out as part of the flats recycling package, help to reduce levels of contamination in the recycling bins and lend themselves to recycling being placed in the bins loose. Reusable bags are being provided on request as part of the flats recycling package roll out on Tower Hamlets Homes estates providing a more sustainable option than reliance on the plastic recycling sacks.

The service needs to ensure that it facilitates access to the recycling service and that residents living in flatted properties are able to easily engage in the service

**Recommendation 5:** Investigate and application small grants programme for small private developments along the lines of the SME energy efficiency programme

**Comments from Service:** 

The roll out of the flats recycling package to a proportion of THH estates has been funded by an allocation of Mayor's Priority Growth Funding. There is no further allocation of this funding beyond the current financial year (2020/21). Alternative sources of funding will need to be sought to expand the roll out of the flats recycling package more widely.

The funding for the energy efficiency small grants comes from the Carbon Offset Fund. This money is from building developments in the Borough that do not meet the energy standards required on site and therefore pay an offset to us. The money is then used on programmes across the Borough to reduce carbon emissions. There is currently no similar grant funding arrangement in place for waste and recycling services.

The service will need to explore whether the activity would qualify for the use of CIL contributions and opportunities to bid for CIL funding. The Community Infrastructure Levy (CIL) legislation enables the Council to allocate between 15% and 25% (depending on circumstances) of the CIL receipts to the Neighbourhood Portion, which is to be spent on local infrastructure priorities agreed with the local communities where development is taking place. In Tower Hamlets, the council gives local people a greater say in priorities and proposals for spending on local infrastructure improvements. Residents may vote for some of the funding (LIF) to be spent on Public Realm improvements, such as more or improved recycling bins,

**Recommendation 6:** Ensure the council's Waste and Recycling Service factors in the cost element for Flats Recycling Package and demonstrate the value of the council's existing initiatives for example mixed-recycling-collection when undertaking cost-benefit analysis

#### **Comments from Service:**

A cost benefit analysis tool developed by ReLondon is being used to highlight the extra costs required to roll out the Flats Recycling Package. This allows the additional costs to the local authority, landlords and housing providers to be quantified. It supports the business case for change allowing the cost and benefits to be quantified.

Whilst the service has been rolling out the Flats Recycling Package on a proportion of THH estates the service intends to promote the Flats Recycling package to other Housing Providers and Landlords and encourage them to implement the package of measures on their own properties. There will be an opportunity to showcase the improvements on completion of the roll out programme.

As a result of the ReLondon research a cost benefit tool has been created for use by Housing Associations and the Boroughs. The aim of the tool is to measure the additional costs and benefits of implementing the Flats Recycling Package covering both set up and ongoing costs.

Whilst cost is one factor for consideration, the cost benefit tool also seeks to quantify the benefits to Housing Providers and Borough and the wider social benefit from the Flats Recycling Package. Diversion of waste to recycling and reduced contamination contribute to improvements in the following measures:

- Reduced CO2 emissions from landfill/energy from waste
- Value of improved residents experience (including reduced litter etc)
- Value of materials diverted from landfill or energy from waste

The service will be evaluating the roll out of the flats recycling package on THH estates and will be collating qualitative and quantitative data to highlight the impact the improvements.

The service will be looking for other managing agents and landlords to follow and implement the flats recycling package on their own estates and the cost benefit tool is available for them to use via the ReLondon website.

**Recommendation 7:** Review the pilot of the food waste to flats scheme and the target audience. Develop plans so that council's Waste and Recycling Service is ready to go when this statutory duty comes in

#### **Comments from Service:**

## **Expanding the food waste service to flats is part of the Tower Hamlets Waste Strategy**

Implementation of the new pilot food waste collection for flats has been delayed due to the covid 19 pandemic. Successive national lockdowns and social distancing requirements have prevented the planning and preparatory work being undertaken to prepare for the implementation of the pilot. An expansion of the food waste collection service to flats is currently not funded.

The government's second round of consultation on the requirements for mandatory separate food waste collections has also been delayed due to the covid pandemic. However, there is an expectation that the consultation documents will be issued

imminently (April 2021). It is anticipated that the consultation documents will set out what new burden funding will be made available, and when, to support the government's mandate, or whether growth funding would be required to expand the food waste service to flats if new burden funding is not made available.

A number of blocks have already expressed an interest in taking part in the pilot, their details have been kept on file. Once covid restrictions are eased the service will look to commence the preparatory work for implementing a pilot for flats, subject to available funding.

**Recommendation 8:** Schools programme, working closely with the young mayor to improve engagement with young people and support behaviour change on recycling

#### **Comments from Service:**

Up until the covid pandemic took hold in March 2020 waste services had been delivering a schools engagement programme via a series of in person classroom, assembly or activity sessions. Also as noted in the challenge session report, the council's Materials Sorting Facility (MRF) contractor has hosted school visits to the MRF education facility.

The recurring lockdowns, shutting of schools and social distancing measures has meant this programme of engagement had to be put on hold. Going forward the service proposes to develop a suite of online educational materials that can be utilised by schools in the classroom or home learning environment.

Site visits to the MRF education facility and other activities and events will be organised when the covid situation eases sufficiently for face to face engagement events to be carried out safely.

With the support of the Communications team the service will engage with the Young Mayor and other key stakeholders to develop a comprehensive package of engagement and behaviour change resources.

**Recommendation 9:** Using Influencers of particular age groups (18-34) to engage, motivate and channel key messages to improve behaviour change on recycling

## **Comments from Service:**

Ensuring communications activities are relevant to all age groups is an important part of our engagement work.

Whilst it is accepted that the use of influencers on Instagram is a common and successful way to promote lifestyles and brands and engage with the 18 to 34 year age group, their effectiveness to promote council services is uncertain.

The service will look to work with the Communications team and engage with the Young Mayor and Youth Council to get ideas and input into developing a communication strategy and action plan that will incorporate appropriate communications channels for target audiences

Recommendation 10: Improving recycling education messaging so there is a common framework of understand from residents

### **Comments from Service:**

The service will be developing a communications plan based on the latest industry research, with the ability for us to get feedback on our proposed approach from experts at ReLondon.

The research carried out by ReLondon highlighted that residents often perceived information from different sources as contradictory and often applied their own "rule of thumb" when deciding if an item can be recycled. The research found that clear and visible signage on the recycling bins and in the bin stores and posters, highlighting recycling messages, displayed in central locations ensured residents would have easy access to clear and reliable information.

Communication material has been developed for the flats recycling package. The communication material is being rolled out on the THH estates as part of the roll out of the flats recycling package.

The communication material is also available for managing agents and landlords to download or they can request leaflets and posters. The materials all have the same branding and messaging to ensure there is a consistent approach to educating

residents on recycling and waste management. The design, language and content follow WRAP guidance who have researched the best approach for recycling messages.

The service will be working with the Communications team to improve the information available to residents, to ensure they have access to information about what happens to the waste and recycling that they place out for collection.

**Recommendation 11:** Recycling performance targets to be more ambitious (stretched) not just realistic and resident contribution to be framed in how progress is being made a local level

#### **Comments from Service:**

The recycling rate set by the Mayor of London in the London Environment Strategy is for London to recycle 50% of Local Authority Collected Waste by 2025 with an aspirational target of 50% of Household Waste to be recycled by 2030. The target is

ambitious and the ReLondon report on the research project states it will be challenging to meet the target with current levels of resources and existing legislation.

To contribute to London's overall recycling rate Tower Hamlets set an ambitious target of 35% of Household Waste to be recycled by 2022 within the Tower Hamlets Waste Strategy 2018 to 2030. The recycling target for 2020/21 is 22%. A recycling target for 2021/22 will be set as part of the service planning process. We are re-evaluating our recycling target based on forecast impact of rolling out the flats recycling package between 2021/22 and 2022/23

The findings of the ReLondon research project have highlighted the particular challenges faced by London Boroughs that have a high proportion of residents living in flats. Through the research the barriers to recycling have been found to be many and complex and despite improvements in capture and recycling rates being achieved on the estates that took part in the research it is important to note the improvements were from a very low base.

Monitoring recycling performance is currently undertaken at the recycling round level, the service is however trialling on board weighing equipment on two refuse collection vehicles. This technology may facilitate a better understanding of recycling performance on a site by site basis in the future. Monitoring the impact of the roll out of the flats recycling package on THH estates is being undertaken and will give the service some quantitative and qualitative data regarding the impact the flats recycling package is having on these estates.
