COUNCILLOR BEX - SCRUTINY LEAD FOR CHILDREN AND EDUCATION

- 1. The most recent committee meeting was on September 2nd. While I updated the committee following this meeting, I'd like to highlight one further outcome from that meeting, which shows the importance of hearing directly from our children and young people. One of the young people who addressed the committee raised important issues around the current Year 12 and Year 13 cohorts having missed out on the preparation that Year 11 exams gives, because of the Pandemic. As a result of this young person's contribution, the committee meeting on 21/10 will focus partly on what is being done to address the lack of exam-preparedness in this cohort.
- 2. In addition to the above, October's meeting will examine a high-level overview on the financial trends within the department, to set the scene for the upcoming budget. We will also be investigating whether the voice and needs of children are at the heart of the School Streets programme. I am happy to provide a verbal update on any of these at the main Overview and Scrutiny meeting which will follow a few days after this sub-committee.
- 3. In the meeting on 25/10, I will provide a verbal update on the recent SEND inspection, and the plans within the sub-committee to scrutinise the outcome and subsequent improvement works.
- 4. Outside of committee meetings, I have met with the Director and Cabinet Member for verbal updates. I also chaired a meeting to devise a Scrutiny Dashboard, which was attended by some other members. Initially, this will take the form of sharing the current CSC dashboard, but there is a larger project being undertaken to improve reporting on other indicators, and this dashboard project will therefore be one that I will periodically bring to the committee for progress review
