The Council rose to observe a minute's silence.

2. DECLARATIONS OF DISCLOSABLE PECUNIARY INTERESTS AND OTHER INTERESTS

The Director of Legal and Monitoring Officer advised that the Standards Advisory Committee had agreed a general dispensation to all Councillors in respect of matters relating to the Council Tax and also on Housing where the Councillor (or spouse or partner) holds a tenancy or lease with the Council. Members did not therefore have to declare a DPI in respect of these matters.

Councillor Kahar Chowdhury declared a Non Disclosable Pecuniary Interest in agenda item 5, Budget and Council Tax 2022/23, in relation to any budget proposals that affected care services. This was due to his wife's employment.

3. TO RECEIVE ANNOUNCEMENTS (IF ANY) FROM THE SPEAKER OF THE COUNCIL OR THE CHIEF EXECUTIVE

There were none.

4. TO RECEIVE PETITIONS

4.1 Petition regarding Complete Cycleway 2

Dan Simpson and others addressed the meeting on behalf of the petitioners, and responded to questions from Members. Councillor Kahar Chowdhury, Cabinet Member for Highways and the Public Realm then responded to the matters raised in the petition

He noted that improving walking and cycling routes in the Borough is a key priority of the Council, as set out in its Transport Strategy. Therefore, the Council were working closely with TfL on a number of initiatives, including:

• Working to identify improvements to the cycle network. This included: delivering Cycleway 2, (which is on the TfL network), and changes to the network at Mile End Road and by the Ocean Estate.

• Developing the Whitechapel Road Improvement Programme, including measures to improve the section of highway between Vallance Road and Cambridge Heath Road.

He also recognised that the changes may impact on bus lanes and the local area. Therefore, it was important to secure stakeholders support for the improvements. The Council will continue to work with such partners to do this and identify funding for improvements.

RESOLVED:

1. That the petition be referred to the Corporate Director, Place for a written response within 28 days.

5. BUDGET AND COUNCIL TAX 2022/23

Mayor John Biggs **moved**, the budget and council tax proposals of the Mayor and Executive as set out in the agenda pack. Councillor Candida Ronald **seconded** the proposals.

Councillor Andrew Wood **moved** the amendment set out in the supplementary agenda, but, due to the absence of a seconder, this amendment could not be considered.

Following debate, the substantive Budget for 2022-23, the Council Tax Resolution and the Treasury Management Strategy and Investment Statements and the Capital Report submitted by Mayor John Biggs were put to a recorded vote and were **agreed**.

- 4. To note the Capital Programme, Housing Revenue Account budget and Dedicated Schools budget

- 5. To adopt the Treasury Management Strategy Statement set out in Annex 3 Appendix A attached to the Council report.
- 6. To adopt the Investment Strategy Report set out in Annex 3 Appendix B attached to the report.
- 7. To adopt the Capital Strategy Report (which incorporates the Minimum Revenue Provision Policy Statement) set out in Annex 3 Appendix C attached to the report.

- 1. That the revenue estimates for 2022-23 be approved.
- That it be noted that, at its meeting on 18th January 2022, Cabinet agreed 108,213 as its Council Tax base for year 2022-23 [Item T in the formula in Section 31B of the Local Government Finance Act 1992, as amended (the Act)]
- 3. That the following amounts be now calculated by the council for the year 2022-23 in accordance with Section 31 to 36 of the Local Government Finance Act 1992 as amended and the Local Authorities (Alteration of Requisite Calculations) (England) Regulations 2011.
- (a) £1,334,441,266 Being the aggregate of the amounts which the council estimates for the items set out in Section 31A(2) of The Act **[Gross Expenditure]**
- (b) £1,212,767,651 Being the aggregate of the amounts which the council estimates for the items set out in Section 31A(3) of The Act **[Gross Income]**
- (c) £121,673,615 Being the amount by which the aggregate at 3(a) above exceeds the aggregate at 3(b) above, calculated by the Council, in accordance with Section 31A (4) of The Act, as its council tax requirement for the year (Item R in the formula in Section 31 B of The Act) [Council Tax Requirement]
 (d) £1,124.39 Being the amount at 3(c) above (Item R), all divided by Item T (2 above), calculated by the Council in accordance with Section 31B (1) of The Act, as
 - calculated by the Council, in accordance with Section 31B (1) of The Act, as the basic amount of its Council Tax for the year **[Council Tax]**
- 4. Being the amount given by multiplying the amount at 3(d) above by the number which, in the proportion set out in Section 5(1) of The Act, is applicable to dwellings listed in a particular valuation band divided by the number which in that proportion is applicable to dwellings listed in valuation band D, calculated by the Council, in accordance with Section 36(1) of The Act, as the amount to be taken into account for the year in respect of categories of dwellings listed in different valuation bands. **Tower Hamlets Council Tax:**
