### Challenges Youth Justice Service HMIP Inspection outcome

- The YJS HMIP inspection took place in April 2022, which resulted in an overall judgement of 'Requires Improvement' with the final report published in July 2022.
- The HMIP inspection highlighted good and poor practice across Organisational Delivery, Court Disposals, Out of Court Disposals and Resettlement. The Inspectorate rated the service overall as 'Requires Improvement' with the score achieve 8 out of 36.
- The diagram sets out the overall rating which has been determined by inspecting the organisational delivery and the three practice domains of youth justice.

# Inspection Recommendations

Youth Justice Executive Board Improvement areas

- The HMIP inspection raised 7 recommendations in total that need to be implemented to impact positively on the quality of the Youth Justice Service
- The Executive Board received 4 recommendations and the Head of Youth Justice Service received 3

#### **Recommendation 1**

Review its membership to ensure that the right people, at the right level of seniority, are included to engage actively in achieving better outcomes for YJS children Ensure that there are comprehensive quality assurance arrangements to understand performance and respond to the profile and needs of all children supervised by the YJS

#### **Recommendation 3**

Make sure that all data and management information is accurate, reliable, and enables informed decision-making

#### **Recommendation 4**

Review its out-of-court provision to ensure that the arrangements are effective and support diversion.

#### **Recommendation 5**

Improve the quality of assessment, planning, and service delivery work to keep children safe and manage the risk of harm they present to others

Ensure robust contingency plans are in place for all children that address their safety and wellbeing, and risk of harm to others

#### **Recommendation 7**

Make sure safeguarding and public protection arrangements are comprehensive and understood by all staff.

# Improvement Plan

### Where we need to improve over the next two years?

- A one year statutory Youth Justice Plan has been devised and submitted to the Youth Justice Board alongside a comprehensive Improvement Plan outlining activity for service improvement over the next two years.
- The YJS disproportionality action plan has been included into the Improvement Plan to ensure there is only one plan the service are delivering.
- The development of the Improvement Plan has been based on the HMIP report and with involvement of the YJS staff and partners to ensure there is a shared of understanding and a set of 6 agreed priority actions to take forward.
- The diagram presents the 7 areas for delivery within the Improvement Plan
