Proposed Conditions

- 1. Notices shall be prominently displayed at any area used for smoking requesting patrons to respect the needs of local residents and use the area quietly. Notices restricting the number of smokers to also be displayed at all exits;
- 2. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the LBTH Police Licensing Team.
 - a. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition.
 - b. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises.
 - c. All recordings shall be stored for a minimum period of 31 days with date and time stamping.
 - d. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31 day period.
- 3. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
- 4. The Licence Holder shall ensure that the details of all complaints are recorded in an occurrence book and such book shall be available for police inspection.
- 5. The pavement from the building line to the kerb edge immediately outside the premises, including gutter/channel at its junction with the kerb edge, shall be swept and/or washed, and litter and sweepings collected and stored in accordance with the approved refuse storage arrangements.
- 6. Non-intoxicating beverages, including drinking water, shall be available to patrons throughout the permitted hours for the sale or supply of alcohol.
- 7. No music or amplified sound shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance at the nearest noise sensitive premises.
- 8. Clearly legible notices shall be displayed at all exits from the premises requesting patrons to respect the needs of local residents and to leave the premises and area quietly.
- 9. A dedicated telephone number for the Designated Premises Supervisor or the duty manager shall be maintained for use by any person who may wish to make a complaint and shall be advertised at the premises or on its website.

- 10. The premises shall operate a Challenge 21 or 25 Policy. (TO BE REPLACED BY CONDITION 19)
- 11. A minimum of 1 SIA licensed door supervisors shall be on duty at the premises from 8pm on Fridays and Saturdays until close. They must correctly display their SIA licence(s) when on duty so as to be visible. (TO BE REPLACED BY CONDITION 16)
- 12. Loudspeakers shall not be located in the entrance and exit of the premises or outside the building.
- 13. On the first and second floor of the premises, the supply of alcohol at the premises shall only be by waiter/waitress service and to a person seated taking a substantial table meal there and for consumption by such a person as ancillary to their meal.
- 14. No collections of waste or recycling materials (including bottles) from the premises shall take place between 11pm and 8am hours on the following day.
- 15. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of
 - a. the incident and will record the following:
 - b. all crimes reported to the venue
 - c. all ejections of patrons
 - d. any complaints received concerning crime and disorder
 - e. any incidents of disorder
 - f. all seizures of drugs or offensive weapons
 - g. any faults in the CCTV system, searching equipment or scanning equipment
 - h. any refusal of the sale of alcohol
 - i. any visit by a relevant authority or emergency service.

Conditions agreed with the Police

- 16. A minimum of 2 SIA licensed door supervisors shall be on duty at the premises from 20:00 hours until close Friday and Saturday. A minimum of 1 SIA licensed door supervisors shall be on duty Thursday directly before a bank holiday Friday and Sunday directly before a bank holiday Monday from 20:00 until close. Additional SIA shall be employed on a risk assessment basis. These risk assessments are to be written and reviewed yearly, and made available to Police as soon as practicable. (TO REPLACE CONDITION 11)
- 17. In the event that a serious assault is committed on or directly outside of the premises (where staff witness) or appears to have been committed the management will immediately ensure that:
 - a. the police (and, where appropriate, the London Ambulance Service) are called without delay;
 - b. the crime scene is preserved so as to enable a full forensic investigation to be carried out by the police; and

- c. such other measures are taken (as appropriate) to fully protect the safety of all persons present on the premises
- 18. All front of house staff shall complete welfare and vulnerability awareness training as part of their induction process to work at the premises. This training shall be documented and repeated/refreshed at yearly intervals.
- 19. A challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram (TO REPLACE CONDITION 10)

Conditions offered to EHO and Licensing

- 20. The use of the outside area of the premises will cease at 2100 hours each day, save for a maximum of six smokers.
- 21. Premises licence holders should ensure that any customers drinking and/or smoking outside the premises shall do so in an orderly manner and are supervised by staff so as to ensure there is no public nuisance or obstruction of the public highway.
- 22. Customers permitted to temporarily leave and re-enter the premises e.g. to smoke, after 2100 shall not be permitted to take drinks or glass containers with them.
- 23. After the outside area is closed, the premises licence holder will, do a full sweep of the perimeter of the premises to ensure that any remaining glasses or litter attributed to the premises is removed from the street or the premises window ledges.

Fifty pubs a month shut in first half of year in England and Wales, figures show

Number of pubs open fell to 39,096 by end of June and experts say tax rises in 2025 could result in more closures

Fifty pubs a month closed for good across <u>England</u> and Wales in the first half of this year, with experts warning that tax rises in 2025 could make it even harder for some businesses to keep their doors open.

Analysis by the real estate intelligence company Altus found that 305 pubs were forced to shut their doors permanently in the first six months of the year, meaning the number of pubs in England and Wales fell to 39,096 at the end of June.

The total figure also includes pubs that are vacant and being offered to let, meaning the number of operational pubs is even lower.

Pubs that have "vanished" from the communities they once served have either been demolished and/or converted into other types of use such as homes, offices or even day nurseries, according to Altus.

The rate of closure is lower than the first half of 2023, when 383 pubs vanished, the equivalent to 64 pubs closing every month.

Alex Probyn, the president of property tax at Altus Group, said even more pubs could be forced to close their doors next year as they faced a "double whammy" of extra costs because of inflation and the removal of business rates relief.

Hospitality businesses were given 100% business rates relief by the government between 2020 and 2022 in response to the Covid-19 pandemic. This was then cut to 75%, but will be removed from next April. UKHospitality has estimated that this could cost businesses an extra £928m and lead to bills for some companies quadrupling.

Probyn said: "The last thing pubs need is an average business rates hike of £12,160 next year through inflationary rises and the loss of the discount."

A spokesperson for the British Beer and Pub Association said: "While we know that brewers and pubs pour billions into the economy, their massive contribution to society is priceless, which is why any closure is devastating. Government must use this budget to cut beer duty, reform business rates, and maintain 75% business rates relief so that pubs can remain a home from home."

The analysis by Altus found that the north-west of England was the worst hit, with 46 pubs closing during the six-month period. The south-west and the East Midlands were the areas with the pext highest closures, with 37 each, while Wales had the fewest closures at 15.

Meanwhile, reports suggest the chancellor, Rachel Reeves, is considering raising alcohol duties in next month's budget as she looks to plug what Labour says is a £22bn hole in the public finances. However, this will be damaging for wine and spirits producers, who say they are still dealing with the fallout of the largest single duty increase in 50 years last year, when there was a 20% rise on 85% of wines.

On Friday, figures from HM Revenue and Customs showed there had been a £1.3bn drop in alcohol duty receipts in the 12 months up to the end of August, which the Wine and Spirit Trade Association attributes to a drop in sales caused by the higher duties.

Miles Beale, the chief executive of the WSTA, said: "Last year's damaging reforms to the alcohol excise duty system, including the largest single duty hike in almost 50 years, have hit businesses, consumers and the government purse. Prices have risen, sales are down, and so is duty income by over £1.3bn."

It is calling on the government to freeze duty on wine and spirits for at least two years to allow sales to recover.

- b) the crime scene is preserved so as to enable a full forensic investigation to be carried out by the police; and
- such other measures are taken (as appropriate) to fully protect the safety of all persons present on the premises
- 3- All front of house staff shall complete welfare and vulnerability awareness training as part of their induction process to work at the premises. This training shall be documented and repeated/refreshed at yearly intervals.

Hi Corinne and Nicola

Many thanks for your time meeting at site yesterday, it was really beneficial to show you around the premises and discuss what we have planned for the site.

As we discussed, the application is for a new pub and restaurant, with the pub on the ground floor and the restaurant on the first floor with a private dining room on the second floor.

The premises, as you know currently holds a licence which is held by a landlord which was a shadow licence previously held by Dirty Bones.

Dirty Bones did previously have a premises licence, (licence number 21557) but this licence unfortunately lapsed when the holding company went into administration. I note this licence did have both on and off sales.

With regards to the operation, as we discussed one of the fundamental parts of my clients intention for the premises is the ability to have outside drinking. The premises benefits from being on a corner of Club Row and Bethal Green Road and has a large pavement area outside both corners and big open glass windows spanning the whole length of the premises.

Although previously, the shadow licence held by the landlord had off sales refused by the committee, as we discussed at site the request for off sales was to allow for deliveries during the Covid period (refused in September 2020, and was not in relation to drinkers stood outside).

With regards to additional conditions please see below four additional conditions my client is happy to offer

1. The use of the outside area of the premises will cease at 2100 hours each day, save for a maximum of six smokers.

- 2. Premises licence holders should ensure that any customers drinking and/or smoking outside the premises shall do so in an orderly manner and are supervised by staff so as to ensure there is no public nuisance or obstruction of the public highway.
- 3. Customers permitted to temporarily leave and re enter the premises eg to smoke, after 2100 shall not be permitted to take drinks or glass containers with them.
- 4. After the outside area is closed, the premises licence holder will, do a full sweep of the perimeter of the premises to ensure that any remaining glasses or litter attributed to the premises is removed from the street or the premises window ledges.

My client is happy to offer these additional conditions, on the basis of the withdrawal of your representations, to help alleviate your concerns with regards to the operation of the premises.

As you know, we have only had one representation from a member of public behind on Whitby Street. Their representation refers to the premises being a nightclub, which as you know this premises is not. I have contacted that resident to meet on site and explain the proposed premises.

My client is fully aware of the responsibility of managing an outside area and will have strong operational policies and procedures in place to ensure that this area is managed effectively and without causing any nuisance to local nearby residents or obstructing the highway. With regards to numbers, my client is not expecting to have any more than 35 people outside at any one time. As we discussed at site, it will be difficult for us to offer this as a condition as the premises will not have door supervisors on at all times and therefore would be an unnecessary burden on my client to employ someone specifically to count numbers of people outside at all times.

If off sales is not permitted, it is highly likely my client will not take the site and it will remain disused and empty. As explained yesterday, the premises has been a pub since the 1800s with the incredible mirrors and flooring, and we really want to restore the site to its former beauty.

I would be grateful if once you have spoken to your managers, you will come back to me with any thoughts on the above conditions and whether you would be happy to withdraw your representation.

I will keep you updated with my discussions with the resident who I am hoping once we have explained her proposal will be in a position to withdraw, also.

Again, many thanks for your time at the meeting earlier, it was lovely to see you both.
